RULES AND REGULATIONS OF THE WATER EQUIPMENT RENTAL PLACE

1. The rental shop is open daily from 10 a.m. to 6 p.m.
2. The type of equipment available and the cost of its rental is determined by the current price list available at JAK TU ŁADNIE and at www.jaktuladnie.com
3. The rented equipment is in full technical working order and in the same condition should be returned to the lending library.
4. Return of equipment after the time declared at the time of rental will result in an additional fee in accordance with the applicable price list of the rental company. Time will be rounded up to 0,5 h in favor of the Lessor.
5. The risk of accidental loss or damage to the equipment shall be borne by the Lessee during the rental period.
6. It is forbidden to lend or rent or transfer in any other form, the equipment to third parties.
7. The rented equipment may be used only for non-commercial purposes and only for your personal use.
8. The Lessee is obligated to immediately report any problem related to the use of the equipment (including malfunction, accident) to the employee of the rental company and to immediately return the equipment to the rental company in the event of determining that it is not fully operational.
9. Self-repair, modification or replacement of parts in the rented equipment is prohibited.
10. The provisions for water equipment shall apply mutatis mutandis to accessories rented together with the equipment (e.g. life jackets, paddles).
11. The Lessee at the time of its rental of the equipment declares that:
 - a. is an adult and sober; a minor over 16 years of age may rent water equipment only with the consent of an adult authorized to supervise the minor, who assumes full responsibility for the rented equipment and the consequences of the actions of the minor using it,
 - b. will make payment for the rental of the equipment according to the price list indicated in paragraph 2
 - c. intends to use the equipment and its equipment as intended,
 - d. intends to return the equipment to the place of rental together with the equipment, technically efficient, in undamaged condition, within the time period consistent with the in accordance with the declared return time,
 - e. has the necessary knowledge of the operation of the equipment and undertakes to take care of the equipment and use it safely and for its intended purpose
 - f. shall pay the cost of repairing the damaged equipment or purchasing new equipment in the event of damage, loss, theft, and shall be fully responsible for the equipment except for item 12 below.
12. Watercraft and motorboats are insured for liability and AC insurance. In the event of any event causing damage, the Lessee is obliged to immediately fill out a damage report and immediately, i.e. on the day of the insured event, inform the Lessor of the damage. In the case of liquidation of damages within the scope of insurance, the Lessor shall retain the deposit in full. In the case in which the captain of the Yacht is under the influence of intoxicants, alcohol or other derivative substances, the Lessee shall take full financial responsibility for the damage and cover the value of lost profits in an amount not exceeding the value of the weekly charter within 5 working days from the day of the summons.
13. In case of destruction or loss of the rented equipment or its equipment or accessories due to accident, theft or loss, the Renter shall be obliged to reimburse the Company for the amount corresponding to the value of the equipment, its equipment or accessories, possible repair of the damaged equipment in accordance with the applicable price list:
 - KAYAK – 3.000 ZŁ
 - SUP/ PADDLE BOARD – 2.000 ZŁ
 - WAKEBOARD – 1500 ZŁ
 - WATERSKI – 1500 ZŁ
 - ROW – 250 zł
 - HELMET – 250 ZŁ
 - LIFE JACKET – 250 zł
 - BICYCLE – 2.000 ZŁ
 - CHILD SEAT – 500 ZŁ
14. The Company shall not be liable for accidents and damages, both to the borrower and third parties, arising during the use of the equipment by the borrower, provided that the accidents or damages are not the result of the existence of defects inherent in the borrowed equipment, and accidents and damages caused by non-compliance with the regulations.
15. In the event that the fact of destruction of equipment is found, a protocol of destruction of equipment should be drawn up. The protocol of destruction is completed by the employee of the rental company with the participation of the renter and is the basis for settlement of the damage caused.
16. The employee of the rental place has the right to refuse to lend equipment when:
 - a. Has a reasonable suspicion that the borrower is under the influence of alcohol or other drugs
 - b. current weather conditions may pose a threat to the life or health of the renter, as well as may adversely affect the technical condition of the equipment
17. At the end of the rental period of the water equipment must be pulled on the sand hand it over to the rental employee and immediately report to the rental office of JAK TU ŁADNIE to settle the rental equipment and return life jackets, helmets, paddles, etc.
18. In the event that there is no employee on the pier to pick up the water equipment, the Lessee is obliged to make a phone call to the number of the Settlement Jak Tu Ładnie: phone. +48 537 171 777 and inform about the end of the lease
19. Unauthorized unmooring of water equipment, or leaving it outside the areas designated for this purpose, is prohibited.
20. Climbing aboard water equipment with hard footwear is prohibited.
21. Each rental watercraft must carry as many belying or life jackets as the number of persons on board. Sailing out without the appropriate number of vests is prohibited.
22. While on a rented watercraft:
 - a. it is forbidden to consume alcohol, smoke cigarettes and take intoxicants,
 - b. do not litter the lake,
 - c. behave in a cultured and moral manner,
 - d. nailing to the shore in places not intended for this purpose, rocky shores and making jumps into the water is prohibited,
 - e. follow the instructions of the rental service and other institutions authorized to issue them,
 - f. use of belying or life jackets is mandatory.
23. Rented bicycles are equipped with front and rear position lights, bell, fenders, basket (applies to some models) and are specially marked. In addition, they may be equipped with a safety cable. The use of bicycles for mountain touring, jumping, stunt riding, racing, etc. is prohibited.
24. The obligations listed in this paragraph also apply to persons who are not Guests of the Settlement Jak tu Ładnie, but use the rental shop. In addition, such persons are required to:
 - a) provide the employee of the rental company with an ID card or other identity document in such a way that it is possible to read its contents and transcribe the data necessary to identify the borrower (photocopying and scanning or taking pictures of the presented documents are excluded),
 - b) in the case of renting watercraft, the presentation of a patent of a motorboat helmsman or sea helmsman or higher degrees of motorboat.
 - c) pay a refundable deposit at the time of rental in order to secure the Lessor's claims arising or likely to arise from the rental of water equipment, in particular the costs associated with the occurrence of any technical defects and equipment shortages (applies only to Guests from outside the Jak Tu Ładnie Settlement)
 - Deposit value when renting by the hour/day:
 - Jet Ski - 500 zł/2000 zł
 - Motorboat - 500 zł/2000 zł
 - Pontoon - 100 zł/500 zł
 - Water bicycle - 100 zł/500 zł
 - Kayak - 100 zł/500 zł
 - Bicycle - 100 zł/500 zł
 - d) in cash or a pre-authorization blockade will be made in the amount of the deposit on the credit card.
 - d) to cover damage caused to the Company's property that exceeds the value of the retained deposit.
25. The deposit referred to in the paragraph above will be returned to the borrower upon receipt and inspection of the borrowed equipment, and in the event of damage after deducting from it the amount corresponding to the value of the damage to the equipment caused during the rental period.
